Article 2 Section 2. Qualifications for Classes of Members. B. Associate. However, an Associate member may not have the right to use on Screen Credits, or in publicity of any kind, or the right to vote. Article 2 Section 3. Admission to membership. The following steps and procedure shall be taken for the admission to active membership B. Applications for membership shall be in writing, signed by the applicant, and submitted together with a payment in an amount equal to the initiation fee, current dues and assessm C. Upon recommendation of the applicant by a two-thirds (2/3) vote of the Board of Direct in the CAS Quarterly. If thirty (30) days after publication no written objections have been accepted to membership. D. In the event that written objections are received, it shall be the sole discretion of the Boo objections and, if found to be unsubstantiated or prejudiced, the applicant shall be accepted E. If applicant is refused membership, any payment submitted by the applicant shall be ref.
